Paperwork: Coach Smith must have the entire 11 page athletic participation packet completed along with a physical and a proof of residency. PLEASE DOUBLE CHECK THAT EVERYTHING IS FILLED IN AND SIGNED CORRECTLY.

## Cost to play on team: All players - \$60

This is for new uniform shirt/ tank top, banquet fee, and balls.

Matches: Matches will consist of three singles games and two doubles games for both the boy's and the girl's team. Once seeded, if your student is seeded number 4 in singles, I cannot guarantee that they will play every single match, but they will have opportunities to fill in and play exhibition games with other teams.

Transportation to and from practices/matches: players need to be dropped off and picked up on time from both practices and matches. I cannot bring students to practice/matches, nor can I take them home. If you choose to carpool with other parents and players on our team, I will need a note signed by the parent telling me of the arrangement. I only need the note one time, not every single time the players carpool. If I do not have a note, the player must ride home with the parent/guardian.

Grades: every student must maintain an average of a D in every class that they are taking in order to remain on the team. If a student's average drops below a D, the student will not be allowed to participate until I have proof that the grade has been pulled up. The student needs to talk to their teacher and show me that they have made efforts to improve. We are students first and athletes second.

When a progress report or report card is sent home from the school, it is the student's responsibility to either bring it to practice to show me, bring me a copy the next day at school, or parents can send me a picture to my email at smithber@rcschools.net . If I do not see the progress report or report card, the student does not play.
